3. AFFILIATE PROGRAM PURPOSE

To create a trusted, incentivized network of certified affiliates who identify and refer talented players to the NEXTGEN Academy and Foundation while ensuring legal and ethical compliance.

4. WHO CAN BECOME AN AFFILIATE?

Eligible Roles:

ANYONE THAT IS APPROVED by NEXTGEN

Affiliate Levels:

- Bronze Academy Affiliate Scout For individuals who refer promising youth players (ages 14–21) to the NEXTGEN Academy.
- Silver Foundation Affiliate Scout For who refer top-tier prospects suitable for NEXTGEN Foundation program.
- Gold Advisory Board Member For respected professionals who support NEXTGEN's growth and outreach.

Requirements:

- Sign the Affiliate Agreement / MoU
- Accept the Code of Conduct
- Complete annual certification

5. RESPONSIBILITIES OF AFFILIATES

- Identify and refer genuine football talent
- Conduct basic verification (age, potential, character)
- Communicate regularly with NEXTGEN coordinators
- Follow ethical and legal scouting guidelines
- Assist with paperwork and trial logistics if needed

6. PLAYER REFERRAL PROCESS

- 1. Identify Player Talent
- 2. Submit IOnline Referral Form
- 3. Internal Review by NEXTGEN
- 4. Trial Invitation or Remote Assessment
- 5. Player Accepted to Academy or Foundation
- 6. Affiliate Receives Fee or Recognition

7. CONTRIBUTION & REWARD STRUCTURE

Stage	Reward type
Profile Shortlisted (you)	Recognition + Priority Processing
Player Accepted (Academy)	Fixed Commission (on Academy revenues of that player)
Player Accepted (Foundation)	% of Development & Advisory Fees (if applicable)
Alumni Success (Pro Deal)	% of Development & Advisory Fees (if applicable)

NEXTGEN may also offer affiliates recognition fees for impactful contributions that:

- Refer players who are accepted into Academy/Foundation programs
- Assist in organizing Foundation events, travel logistics, or onboarding processes
- Actively help expand NEXTGEN's message and network within a region (e.g., coordinating showcases, community sessions, media outreach)

Legal Structure:

- These fees are **not classified as transfer commissions**
- Fully compliant with FIFA's TPO ban (Art. 18ter)
- Processed officially through Foundation invoicing or acknowledgement system

8. ETHICAL SCOUTING CODE

Purpose: To ensure all affiliates uphold standards of integrity, safety, and transparency.

Core Principles:

- 1. Player-centered scouting
- 2. Honest representation
- 3. No hidden fees or exploitation
- 4. Parent/guardian involvement
- 5. Full transparency
- 6. Non-discrimination
- 7. Avoid conflicts of interest
- 8. Confidentiality of data
- 9. Zero tolerance for misconduct
- 10. Compliance with international law & FIFA rules

Commitment Clause: By joining, affiliates agree to abide by this code and accept disciplinary action if breached.

9. SAFEGUARDING & MINORS

- Always seek parental consent for players under 18
- Use official NEXTGEN Minor Participation Waiver
- Comply with FIFA Article 19 on international transfers
- Ensure ethical, safe, and transparent practices

11. TOOLS & SUPPORT PROVIDED

- Affiliate Portal (submission + referral tracking)
- Access to events and trials
- Direct lines to coordinators
- Quarterly webinars + training modules
- Visual marketing assets and affiliate verification
